CONCERNING

HORTICULTURAL PRODUCT IMPORT RECOMMENDATION

BY THE GRACE OF GOD THE ALMIGHTY

THE MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA,

- Considering:
- a. that with Regulation of the Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 concerning Horticultural Product Import Recommendations, as amended by Regulation of the Minister of Agriculture Number 24/PERMENTAN/HR.060/5/2018 concerning amendment to Regulation of the Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 concerning Horticultural Product Import Recommendations, Horticultural Product Import Recommendations have been regulated;
  - b. that to increase the efficiency and results of Horticultural Product imports, it is necessary to change the Regulation of the Minister of Agriculture, as referred to in item a;
  - c. that based on the consideration as referred to in items a and b, as well as to implement Article 88 paragraph (5) of Law 13 Year 2010 concerning Horticulture, it is necessary to establish a Regulation of the Minister of Agriculture concerning Horticultural Product Import Recommendation;

## DECIDES

To stipulate: REGULATION OF THE MINISTER OF AGRICULTURE NUMBER CONCERNING HORTICULTURAL PRODUCT IMPORT RECOMMENDATION

## CHAPTER I GENERAL PROVISIONS

### Article 1

In this Ministerial Regulation what is meant by:

1. Horticulture are all things associated with fruits, vegetables, plant-based ingredients, and floriculture, including mushrooms, mosses, and aquatic plants that serve as vegetables, plant-based medicines, and / or aesthetic materials.
2. Horticultural Products are all products derived from fresh or processed horticultural plants.
3. Import of Horticultural Product is a series of import activities of Horticultural Products from abroad into the custom territory of the Republic of Indonesia.
4. Horticultural Product Import Recommendation, hereinafter referred to as RIPH, is a written statement stating that the Horticultural Products meet the administrative and technical requirements.
5. Horticultural Product Import Business, hereinafter referred to as Business, is a business entity that conducts business activities in the field of Horticultural Product importation that is established and located in the territory of the Republic of Indonesia.
6. Company Registration Number, hereinafter referred to as NIB is the Business' identity that is issued by the OSS Agency after the Business has registered.

7. General Importer Identification Number, hereinafter referred to as API-U, is an identification as a General Importer.
8. Producer Importer Identification Number, hereinafter referred to as API-P, is an identification as a Producer Importer.
9. Entry Point is a seaport, river port, crossing port, airport, post office, international border post, and other places that are considered necessary, that have been designated as an entry point for Horticultural Products.
10. Minister is the minister whose tasks and responsibilities are in the field of horticulture.
11. Director General of Horticulture, hereinafter referred to as Director General, is a senior high-ranking official in the Ministry of Agriculture who performs duties and functions in the field of Horticulture.
12. Head of the Plant Variety Protection and Agriculture Licensing Center, hereinafter referred to as Head of PVTTP Center, is a senior high-ranking official in the Ministry of Agriculture who performs duties and functions in the field of protection of plant variety and agricultural licensing.

#### Article 2

The scope of this Ministerial Regulation includes:

- a. RIPH issuance requirements;
- b. RIPH issuance procedures;
- c. obligations of Businesses; and
- d. sanction provisions.

## CHAPTER II RIPH ISSUANCE REQUIREMENTS

### Part One General

#### Article 3

- (1) RIPH is issued for the following Horticultural Products:
  - a. fresh for consumption; and
  - b. fresh for industrial raw materials.
- (2) Horticultural Products, as described in paragraph (1), are listed in Appendix I, which is an integral part of this Ministerial Regulation.

#### Article 4

- (1) Horticultural Product Imports can be conducted by:
  - a. Businesses;
  - b. social institutions; or
  - c. representatives of foreign countries / international institutions;

- (2) Businesses, social institutions or representatives of foreign countries / international institutions, as referred to in paragraph (1), can conduct Horticultural Product Imports after receiving an import license from the minister that is in charge of government affairs in the field of trade after receiving an RIPH from the Director General on behalf of the Minister.
- (3) RIPH, as referred to in paragraph (2), is an attachment that is inseparable from the import license.

#### Article 5

- (1) Businesses, social institutions, or representatives of foreign countries / international institutions can submit RIPH applications at any time.
- (2) RIPH applications, as referred to in paragraph (1), are processed on business days.
- (3) RIPH applications for the following year can be submitted starting in November of the current year.

#### Article 6

- (1) In the case of supply and price stabilization, Horticultural Product Imports only can be conducted by State Owned Enterprises.
- (2) State Owned Enterprises in conducting Horticultural Product Imports, as referred to in paragraph (1), must receive a tasking from the minister that is in charge of government affairs in the field of State Owned Enterprises.
- (3) The Minister that is in charge of government affairs in the field of State Owned Enterprises, in giving the tasking as referred to in paragraph (2), is based on the results of an economic limited coordination meeting at the minister-level.

#### Article 7

- (1) Social institutions, as referred to in Article 4 paragraph (1), must be legally incorporated that is established according to Indonesian law and be located in Indonesia.
- (2) Representatives of foreign countries / international institutions, as referred to in Article 4 paragraph (1), must be located in Indonesia.

#### Article 8

Imports of Horticultural Products for:

- a. testing, research, and scientific development needs;
  - b. samples that are not for sale; and/or
  - c. private passengers, carrier crew.
- are exempted from this Ministerial Regulation.

#### Article 9

- (1) Businesses that import strategic Horticultural Products must develop strategic horticultural commodities domestically.
- (2) The strategic horticultural commodity development requirement, as referred to in paragraph (1), is in accordance with the type of strategic horticultural commodity that is requested in an RIPH.

- (3) Development of a strategic horticultural commodity, as referred to in paragraph (1), is [to be] regulated in a Regulation of the Minister.

## Part Two Requirements

### Article 10

To obtain an RIPH, Businesses, social institutions, and/or representatives of foreign institutions / international institutions, as referred to in Article 4, must meet administrative requirements and technical requirements.

### Article 11

Administrative requirements, as referred to in Article 10, for Businesses include:

- a. deed of company's establishment and the most recent amendments to it;
- b. Identity Card (KTP) of the head of the company;
- c. company registration number that is valid as an API-U for general [importers];
- d. company registration number that is valid as an API-P for production [importers];
- e. statement to use imported horticultural products in accordance with the RIPH application for businesses that hold an API-P, in accordance with Form-1;
- f. realization of Horticultural Product imports report for the previous RIPH for realized and unrealized [imports] in accordance with the RIPH, in accordance with Form-2; and
- g. a stamped statement stating that the documents submitted are accurate and valid, in accordance with Form-3.

### Article 12

Administrative requirements, as referred to in Article 10, for State Owned Enterprises that receive tasking, as referred to in Article 6 paragraph (2), include:

- a. a tasking letter from the minister that is in charge of government affairs in the field of State Owned Enterprises; and
- b. company registration number that is valid as an API-U.

### Article 13

Administrative requirements, as referred to in Article 10, for social institutions include:

- a. KTP and/or any identification of the social institution's leader;
- b. deed of establishment of social institution, and the most recent amendments to it;
- c. designation as a social institution from an authorized agency;
- d. grant award information from the country of origin;
- e. information of the prospective beneficiary; and
- f. a statement not to sell Horticultural Products;
- g. a stamped statement stating that the documents submitted are accurate and valid, in accordance with Form-3.

### Article 14

Administrative requirements, as referred to in Article 10, for representatives of foreign countries/international institutions include:

- a. identity of leaders and/or representatives that have been assigned / put in charge;
- b. a statement [that product is] for internal needs and not intended for circulation; and
- c. a stamped statement stating that the documents submitted are accurate and valid, in accordance with Form-3.

#### Article 15

(1) Technical requirements, as referred to in Article 10, include:

- a. fresh Horticultural Products must comply with the Fresh Food of Plant Origin (PSAT) safety provisions, in accordance with the provisions of the laws and regulations;
  - b. fresh Horticultural Products that are imported for the first time from their country of origin, must be accompanied by an analysis result report on the risk of disease-carrying organisms on quarantined plants from the Agricultural Quarantine Agency;
  - c. a certificate of Good Agriculture Practices (GAP) or an equivalent certificate that is internationally recognized and still valid until the end of the import year;
  - d. a registration of the packing houses issued by the authorized agency from the country of origin that is still valid until the end of the import period conducted;
  - e. a statement from exporters of the country of origin concerning the production capacity of the registered or Good Agriculture Practices (GAP) certified garden / farm land; and
  - f. Horticultural Products that are imported meet specified characteristics.
- (2) The technical requirements, as referred to in paragraph (1) item c, item d, and item e, are to be translated into Indonesian by a sworn translator.
- (3) Further provisions regarding characteristics, as referred to in paragraph (1) item f, are determined by the Director General on behalf of the Minister in the form of a Ministerial Decree.

### CHAPTER III RIPH ISSUANCE PROCEDURES

#### Article 16

- (1) Businesses, BUMN, social institutions, and/or representatives of foreign countries / international institutions, as referred to Article 4 paragraph (1), that will import Horticultural Products must submit an RIPH application online to the Director General through the Head of PVTTP.
- (2) The application, as referred to in paragraph (1), must at a minimum contain the following information:
  - a. name and address of the company;
  - b. name and address of the company's leader;
  - c. number and date of the application;
  - d. name of the Horticultural Product;



- e. tariff/HS code of Horticultural Product;
  - f. country of origin;
  - g. planned import volume;
  - h. planned Entry Point; and
  - i. planned import time.
- (3) The application, as referred to in paragraph (1), is completed with the administrative requirements and technical requirements, as referred to in Article 11 through Article 15.

#### Article 17

- (1) The application, as referred to in Article 16, uses:
- a. Form-4, RIPH application for fresh [products] for consumption; and
  - b. Form-5, RIPH application for fresh [products] for industrial raw materials.
- (2) Head of PVTTP Center, after receiving an application, as referred to in Article 16, in a period of no more than 3 (three) working days, checks the completeness of the documents' administrative requirements.

#### Article 18

If the results of the document examination of administrative requirements, as referred to in Article 17 paragraph (2), are:

- a. complete, it is delivered to the Director General, in accordance with Form-6; or
- b. incomplete, it is rejected online.

#### Article 19

- (1) Director General, after receiving an application, as referred to in Article 18 item a, verifies and validates technical requirements within a maximum period of 5 (five) working days.
- (2) If the verification and validation results, as referred to in paragraph (1):
- a. are in accordance with technical requirements, an RIPH is issued, in accordance with Form-11; or
  - b. are not in accordance with technical requirements, it is rejected.
- (3) RIPH that are issued, as referred to in paragraph (2) item a, are delivered to the Business and the Indonesia National Single Window (INSW) portal through the Head of the PVTTP Center.
- (4) Rejection, as referred to in paragraph (2) item b, is delivered online to the Business through the Head of the PVTTP Center, along with the rejection reason.
- (5) RIPH that are issued, as referred to in paragraph (3), are valid for 1 (one) calendar year, as long as they meet technical requirements, as referred to in Article 15 paragraph (1) item c and item d.

#### Article 20

- (1) In the event of unforeseeable circumstances (*force majeure*), Businesses, social institutions, or representatives of foreign / international institutions, as referred to in Article 4 paragraph (1), can submit the RIPH application offline.

- (2) An event of unforeseeable circumstances (*force majeure*), as described in paragraph (1), is an event that occurs outside of human capability and cannot be avoided so that an activity cannot be carried out.
- (3) An event of unforeseeable circumstances (*force majeure*), as described in paragraph (1), is declared via a statement letter from the Director General.

#### Article 21

- (1) RIPH, as referred to in Article 19 paragraph (5), is declared still valid if a Horticultural Product has been loaded on a means of transport from the country of origin no later than December 31 of the current year.
- (2) Loading onto a means of transport, as referred to in paragraph (1), is proven with:
  - a. *cargo manifest*; and
  - b. *Bill of Lading* (B/L) or *Air Way Bill* (AWB).
- (3) Horticultural Products, as referred to in paragraph (1) arrive in Indonesia no later than 60 (sixty) calendar days since being loaded onto a means of transport from the country of origin and is proven with an Imported Good Notification (PIB) document.

#### Article 22

- (1) Businesses that have obtained RIPH, as referred to in Article 19 paragraph (3), can make changes to [their] RIPH.
- (2) RIPH changes, as referred to in paragraph (1), are valid *mutatis mutandis*, in accordance with the provisions of Article 16 through Article 20.
- (3) RIPH that are amended, as referred to in paragraph (1), is declared still valid if the Horticultural Product is loaded on the means of transportation from the country of origin no later than the date of the new RIPH's issuance, proven with:
  - a. *cargo manifest*; and
  - b. *Bill of Lading* (B/L) or *Air Way Bill* (AWB).
- (4) Horticultural Products, as referred to in paragraph (1) arrive in Indonesia no later than 60 (sixty) calendar days since being loaded onto a means of transport from the country of origin and is proven with an Imported Good Notification (PIB) document.

#### Article 23

Form-1, Form-2, and Form-3, as referred to in Article 11, Form-4 and Form-5, as referred to in Article 17, Form-6, as referred to in Article 18, and Form-7 as referred to in Article 19, as contained in Appendix II, is an integral part of this Ministerial Regulation.

#### Article 24

Further provisions concerning RIPH issuance procedures, are in accordance with statutory provisions in the field of Integrated Business Licensing Online / *Online Single Submission* (OSS).

## CHAPTER IV OBLIGATIONS OF BUSINESSES

#### Article 25

- (1) Businesses that receives an RIPH must submit the RIPH to the minister who conducts government affairs in the field of trade for the issuance of a Horticultural Product Import license no later than 2 (two) months from the RIPH's online issuance.
- (2) Businesses that do not submit RIPH, as referred to in paragraph (1), [that] RIPH is not valid.

#### Article 26

If there is a legal problem related to an RIPH's issuance, the RIPH application is not issued until a court decision that has permanent legal force.

### CHAPTER V SANCTION PROVISIONS

#### Article 27

- (1) Businesses that violates the provisions as referred to in Article 9, are sanctioned in the form of not being issued an RIPH for a period of 1 (one) year.
- (2) Businesses that violates the provisions as referred to in Article 11 item e, are sanctioned in the form of not being issued an RIPH for a period of 1 (one) year and pulling Horticultural Products from circulation.
- (3) Businesses that violates the provisions as referred to in Article 11 item g, are sanctioned in the form of not being issued an RIPH for a period of 3 (three) years.
- (4) Social institutions that violate provisions as referred to in Article 13 item f, are sanctioned in the form of not being issued an RIPH for 2 (two) years and pulling Horticultural Products from circulation.
- (5) Social institutions that violate provisions as referred to in Article 13 item g, are sanctioned in the form of not being issued an RIPH for 3 (three) years.
- (6) Businesses that violates the provisions as referred to in Article 15 paragraph (1) item f, are sanctioned in the form of not being issued a RIPH for 2 (two) years.
- (7) Businesses that violates the provisions as referred to in Article 25 paragraph (1) twice in one year, are sanctioned in the form of not being issued an RIPH for 2 (two) years.

### CHAPTER VI TRANSITIONAL PROVISIONS

#### Article 28

- (1) RIPH that have been issued before this Ministerial Regulation comes into force, remain valid until the RIPH's expiry.
- (2) RIPH applications submitted before this Ministerial Regulation comes into force are processed in accordance with the Regulation of the Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 concerning Horticultural Product Import Recommendation, as amended by Regulation of the Minister of Agriculture Number 24/PERMENTAN/HR.060/11/2017 concerning Amendment to Regulation of the

Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 concerning Horticultural Product Import Recommendation.

CHAPTER VII  
CLOSING PROVISIONS

Article 29

At the time this Ministerial Regulation comes into force, Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 concerning Horticultural Product Import Recommendation (State Gazette of the Republic of Indonesia Number Year 2017 Number 1674), as amended by Regulation of the Minister of Agriculture Number 24/PERMENTAN/HR.060/11/2017 concerning Amendment to Regulation of the Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 concerning Horticultural Product Import Recommendation (State Gazette of the Republic of Indonesia Number Year 2018 Number 743) are revoked and declared invalid.

Article 30

This Ministerial Regulation shall go into effect on the date it is enacted.

So that it may be known to all men, it is ordered that this Regulation of the Minister of Agriculture be included in the State Gazette of the Republic of Indonesia.

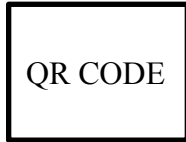

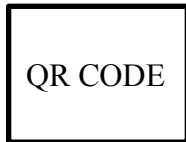
